#### SUMMARY OF DUTIES AND RESPONSIBILITIES:

- 1. Responsible for the planning and delivery of lectures and seminars on the Pedagogy module as part of the BA Voice (Performance & Pedagogy) course, within the Department of Popular Music and Voice
- 2. Responsible for the overall module planning and delivery, including all aspects of the assessment process
- 3. Assisting and facilitating student placements and other external events relevant to the module
- 4. Acting as a member of any assessment panels of live assessments work as well as assessing any relevant student work submitted via the VLE
- 5. Working closely with the Academic Managers in the Department of Popular Music and Voice to develop the voice provision
- 6. Representing the discipline of voice in the development of departmental strategies and curriculum

#### **DUTIES:**

1. *The role-holder will:* Deliver teaching at undergraduate level, as agreed annually with the Academic Manager



- 2. Work with TEL, AV, facilities, student administration and examination areas as necessary to ensure an exceptional student experience
- 3. To attend planning meetings with the Academic Manager and other BA Voice Lecturers, to ensure quality content and clear channels of communication across the department
- 4. To facilitate student assessment and provide feedback to a range of student work in line with Conservatoire guidelines
- 5. Work with Marketing & Recruitment, to undertake student recruitment and marketing activities as defined by department heads.
- 6. Represent the Conservatoire internally and externally when required (e.g. showcases, graduation, productions and recruitment events.
- 7. To take part in staff development events in order to share good practice in your specialist area. To co-operate in any staff development activities required to effectively carry out the duties of the post and to participate in the Conservatoire Appraisal Scheme.
- 8. To comply with all Conservatoire policies and procedures.

Any other reasonable duties commensurate with the level of the post, which may be required from time to time.

- 1. Auditions, Open Days and any other activities without contracted hours would be paid additionally in agreement with the Academic Manager
- 2. Duties will inevitably develop and change as the work of the conservatoire changes to meet the needs of its service.
