- 17. Create SMART targets, record and monitor progress against them. Implement positive interventions where needed, for students undertaking identified modules.
- 18. Apply theoretical understanding of effective practice in teaching, learning and assessment drawing on research and other evidence.
- 19. Consider and employ the most effective delivery methods, including blended learning and technology enhanced learning.
- 20. Carry out internal verification duties in line with quality assurance processes.
- 21. Undertake review processes to develop and improve identified course(s).
